
# MARK YOUR CALENDAR MGA 63<sup>RD</sup> ANNUAL MEETING

# What YOU SHOULD KNOW about ADVANCE DIRECTIVES



As a person with a chronic illness, you have a say in the health care you receive. When you are ill, your doctor should explain what treatments there are for your illness so that you can decide which one is best for you. But if you were too ill to understand your treatment choices or to tell your doctor what treatment you want:

- Who would you want to make decisions for you?
- What type of health care would you want?
- What health care wouldn't you want?

Questions like these may be hard to think about, but they're important. That's why MGA wants you to know about a legal form you can complete. It's called an **Advance Directive**.

What is an Advance Directive? An advance directive is a legal form that helps your doctors and family members understand your wishes about health care. It can help them decide about treatments if you are too ill to decide for yourself. For example, if you are unconscious or too weak to talk. There are two types of advance directives: durable power of attorney for health care and a living will.

Your advance directive is used only when you aren't able to make decisions yourself.

A durable power of attorney for healthcare lets you name the person you trust to make health care decisions for you if you can't make them yourself – your "health care agent." He/she will have the legal right to make health care decisions for you. You can choose any adult to be your agent. It's best to choose someone you trust, who knows you well and who knows your values. You should make sure the person is willing to serve as your agent. If you don't choose an agent, your doctor will choose someone to make decisions for you in the following order: legal guardian (if you have one), spouse, adult child, parent, sibling, grandparent, grandchild, or a close friend. Your health care team, or a court, will make decisions for you if none of the above is available.

A **living will** is a legal form that states what kinds of treatments you would or wouldn't want if you become ill and can't decide for yourself. It can help your health care agent and your doctor make decisions the way you want them to. Writing down what kind of treatment you would or wouldn't want can help make it easier for those who are asked to make decisions for you. Talk with your family, your health care agent, and your doctor about your wishes so they won't have to wonder what you want and if they're doing the right thing. If you don't have a living will, decisions will be made for you based on what is known about you in general and about your values. That's why it's important to discuss your wishes with your loved ones, your doctors, and your health care team.

You may change or cancel your **advance directive** at any time. In fact, you should review your advance directive periodically, especially if there is a change in your health, to make sure it's up to date. If you change it, be sure to tell your health care team and have them put it in your health record. Share your new directive with your family members and other loved ones.





It's been four years since I closed the NY MG Alliance office and asked MGA of WPA to take over. They have done a wonderful job through the years. I commend the staff, volunteers and Maree Gallagher, the Executive Director. She made the transition quite easy for me. As I read the MGA Spring newsletter, I was overjoyed to see how committed my former donors are to the cause. You are still donating! Wow!! It touches my heart to see all the familiar names. I thank you all for believing in me, and my decision, and believing in the MG Association of W.PA. My decision was based on

their integrity, commitment and love for the myasthenic patient.

As I have mentioned, I closed the NY office (it was a one person office – me!) when I was diagnosed with breast cancer. Now, four years later, so far, so good. In 2015, I was diagnosed with CML (Chronic Myeloid Leukemia). I'm happy to say it is now in remission, and I'm feeling better.

I am co-host of a community television show, Cancer Tamer Talk Show (www.cancertamer.org), educating the community and interviewing doctors, lawyers, and fitness professionals, while discussing my diagnosis with the founder of the show, Dr. Charley Ferrer. We also do workshops in the community. In between helping my mom, who is 90, I also run a support group for kids who have been bullied. In my "spare" time, I'm learning to play the ukulele, and enjoying time with my family.

Whatever time you have on this earth, I encourage you all to start one new thing that you never did before and enjoy it!
